 - a. Unfortunately, FINNCHAM continues to have administrative problems related to its legal formation, its bank account, and even its CNPJ, when consulted, returns as Inapita. This is preventing the possibility of regularizing the bank

account and charging the members' annuity. Perhaps to solve the problem temporarily, charge private partners or companies that accept a receipt.
